### **§ 1 Definitions**

1. "Organizer" - Jaguar Tomasz Chwiłowicz, with registered office at: Dworcowa 62, 62-400 Słupca, Poland, operating under NIP: 667-104-48-32, REGON: 311085346.
- "Participant" - a natural person with full legal capacity who is a consumer within the meaning of Article 22 of the Civil Code (Journal of Laws of 2020, item 1740, as amended) participating in the Promotion "Discount for a photo".
3. "Discount Code" - a discount code including a unique code, entitling to a discount in the amount indicated therein for Goods purchased by the Participant in the Online Store. The discount code entitles to purchase one or more Goods at the same time.
4. "Online Shop" - a service provided electronically to enable Participants to viewing Content, entering into remote agreements, and making payments for goods, maintained is available at <https://pularys.com/> Orders placed in The Online Store is carried out by the Seller in accordance with the Store Regulations.
5. "Seller" - Jaguar Tomasz Chwiłowicz, with registered office at: Dworcowa 62, 62-400 Słupca, Poland, acting under NIP: 667-104-48-32, REGON: 311085346.

### **§ 2 General Conditions**

These terms and conditions ("Terms and Conditions") shall determine the conditions of participation in the "Discount for a Photo" Promotion ("Promotion") and receiving discount codes that can be used within the Online Store to purchase Pularys products at a discount. The purpose of the Promotion is to motivate the Participants to purchase Pularys Products and to promote the products themselves on the Organizer's website.

### **§ 3 Date and Place of the Promo**

- The Promotion is valid until canceled by the Organizer.
- The Promotion is organized on the territory of the Republic of Poland, the Promotion shall be carried out in the Online Shop available at the URL: <https://pularys.com/>
3. The discount code entitles you to a discount on the entire assortment of the store <https://pularys.com/> .
  - 4th Discount code does not entitle to reduce the price of transportation.

#### **§ 4 Promotion Participants**

The Participants in the Promotion shall only be natural persons of full legal age and having full legal capacity who are consumers within the meaning of Article 221 of the Civil Code.

Participation in the Promotion shall be voluntary.

2 The Promotion is not eligible for participation:

(a) entities that, as part of their business activities, have concluded distribution agreements with the Organizer or other agreements whose subject matter is the delivery of products covered by the Promotion.

#### **§ 5 Conditions of Participation**

The Organizer in the Promotion allows the Participants to obtain discount codes in the amount depending on the number of photos ("Photo" or "Photos") of Pularys products purchased through <https://pularys.com/>. Discount codes can be used when purchasing Pularys brand products on the website: <https://pularys.com/> i.e. in the Online Store in accordance with the Store Terms and Conditions.

The amount of the discount depends on the number of photos selected and published by the Organizer on <https://pularys.com/>. The photos must be uploaded by the Participant via <https://pularys.com/>.

a. one Photo chosen means a discount respectively for the store currency: 20 PLN, 5€, 5\$,

b. the two chosen images mean a discount respectively for the currency of the store: 40 PLN, 10€, 10\$,

c. the three selected images mean a discount respectively for the store currency: 60 PLN, 15€, 15\$,

d. the four selected images mean the discount respectively for the currency of the store: 80 PLN, 20€, 20\$,

e. five selected images mean a discount for the store currency respectively: 100 PLN, 25€, 25\$

The committee's decision is arbitrary. The committee does not have to choose any photo.

(3) To obtain a discount code, the Promotion Participant must meet the following conditions:

a. Create an account at: <https://pularys.com/> (hereinafter "Site") by

providing your: name, surname, telephone number and e-mail address,

b. Make a purchase by checking the checkbox confirming your desire to participate in the promotion when placing an order.

c. Upload via the Site at least one photo of a Pularys brand product (hereinafter: "Photo") purchased through the <https://pularys.com/> online store,

d. During the registration referred to above:

I. accept the content of these Regulations,

II. consent to the processing of personal data for the purposes of participation in the Promotion,

III. agree to receive from Pularys Jaguar Tomasz Chwiłowicz, with headquarters at: Dworcowa 62, 62-400 Słupca, Poland, operating under NIP: 667-104-48-32, REGON: 311085346 to the e-mail address given, information about products and services of Pularys brand and promotions related to them and to receive SMS messages information regarding promotion: "Discount for a photo" by marking appropriate fields of the form.

The User declares that he/she has all rights to the Photographs uploaded by him/her in full, they are not limited or encumbered in any way and are free from legal and physical defects, and the User is entitled to dispose of the rights to the Photographs.

(5) Along with uploading a Photo, the User grants the Organizer a free non-exclusive license to use the Photos for the purpose of promoting and presenting Pularys products.

6 Each Participant is entitled to participate in the Promotion multiple times.

(7) Each Discount Code is sent as a discount code to the email address provided. The code must be entered by the Member when making a purchase. The Discount Code is not exchangeable for cash equivalent or other goods or services. The discount code is not tradable. The discount code cannot be combined with other promotions available in the Online Shop. A discount code in the Online Store may be used once when placing a single order and the discount applies to the entire order and cannot be used in parts. A discount code is valid for 90 days.

8. the discount code is not eligible for shipping costs.

The discount resulting from the discount code is calculated as 20 PLN, 40 PLN, 60 PLN respectively. 80 zł or 100 zł from the gross price of each Pularys Product listed next to the Product on the website of the Online Store.

10) The discount resulting from the discount code obtained by the Participant under this Promotion cannot be combined with other promotions and discounts in the Online Store at <https://pularys.com/>.

## **§ 6 Complaints**

Complaints related to participation in the Promotion may be lodged during the Promotion and no later than within 30 days of making the order. Complaints shall be sent by email to the following address: [info@pularys.com](mailto:info@pularys.com).

Complaints shall be considered by a commission appointed by the Organizer. About the result of the proceedings

The Committee shall notify the Promotion Participant via e-mail, to the e-mail address provided by the Participant, within 30 days from the date of receipt of the complaint by the Organizer.

## **§ 7 Personal Information**

The Administrator of the personal data processed for the purpose of the Promotion is Jaguar Tomasz Chwiłowicz, based at: Dworcowa 62, 62-400 Słupca, Poland, acting under NIP: 667-104-48-32, REGON: 311085346

The following data will be processed for the purposes of the Promotion: name and surname, e-mail address, cell phone number. The personal data shall be used to grant the discount coupons and contact the Participant (if these Terms and Conditions provide for such contact) as well as to process any complaints. Failure to provide personal data makes it impossible to participate in the Promotion and receive a Discount Code.

(3) The legal basis for the processing of data for the purposes of the Promotion is the consent of the Participant (Article 6(1)(a) of the General Regulation on the Protection of Personal Data of 27 April 2016(RODO).

The personal data of Participants collected for the purpose of the Promotion shall be deleted or anonymized no later than 60 days after the end of the Promotion. This shall not apply to personal data which will be necessary to process complaints or other claims, as well as data

whose further processing will be necessary due to the obligations imposed on the administrator by law (e.g. tax law).

5th It is also required to give Jaguar Tomasz Chwiłowicz, with registered office at: Dworcowa 62, 62-400 Słupca, Poland, operating under NIP: 667-104-48-32, REGON: 311085346 consent to the processing of data for marketing purposes and to receive commercial information at e-mail address (and in the form of SMS). Each person has the opportunity to purchase the Pularys product at full price through the store available at <https://pularys.com/> , therefore giving consent is voluntary.

Personal data will be processed by Jaguar Tomasz Chwiłowicz for marketing purposes on the principles described on the website at

<https://pularys.com/pl/pularys/polityka-prywatnosci> . Consent given to Jaguar Tomasz Chwiłowicz. may be withdrawn by the Participant at any time (in accordance with the mentioned

rules), which does not result in the exclusion or forfeiture of a prize in the Promotion.

(6) Personal data shall be protected by technical and organizational measures to guarantee an adequate level of protection, in accordance with applicable regulations.

## **§ 8 Final Provisions**

In the case of amendments to the Regulations, the Participants shall have the right, without any consequences, to withdraw from the Promotion.
